D.C. LAW 4-137

"Hotel Occupancy Tax Increase Act of 1982".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No., 4-394 on first and second readings, May 25, 1982 and June 8, 1982, respectively. Following the Signature of the Mayor on June 21, 1982, this legislation was assigned Act No. 4-203, published in the July 2, 1982 edition of the D.C. Register, (Vol. 29 page 2757) and transmitted to Congress on June 25, 1982 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-137, effective August 14, 1982.

To increase the tax on hotel occupancy, and for other .purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Hotel Occupancy Tax
Increase Act of 1982".

Sec. 2. Section 101 of title I of the Hotel
Occupancy and Surtax on Corporations and Unincorporated
Business Tax Act of 1977, effective March 16, 1978
(D.C. Law 2-58; D.C. Code, sec. 47-3201) is amended as
follows:

- (a) Subsection (f) (D.C. Code, sec. 47-3201(6)) is amended to read as follows:
- "(f) The term 'room' means any room of any kind, other than a bathroom, lavatory, or kitchen, in any part or portion of a hotel, which use or possession is available for or let out for any purpose other than as a place of assembly."; and
- (b) By adding a new subsection (1) at the end thereof to read as follows:
 - "(1) The term 'Washington Convention Center

Enterprise Fund' means the fund established for the Washington Convention Center pursuant to section 6 of the Washington Convention Center Management Act of 1979, effective November 3, 1979 (D.C. Law 3-36; D.C. Code, sec. 9-605) sometimes also referred to in this act as the 'Civic Center'."

Sec. 3. Section 102(a) of title I of the Hotel
Occupancy and Surtax on Corporations and Unincorporated
Business Tax Act of 1977, effective March 16, 1978
(D.C. Law 2-58; D.C. Code, sec. 47-3202(a)) is amended
by deleting the phrase "eighty cents (80¢)" and
inserting the phrase "one dollar (\$1.00)" in lieu
thereof.

Sec. 4. Section 106 of title I of the Hotel
Occupancy and Surtax on Corporations and Unincorporated
Business Tax Act of 1977, effective March 16, 1978
(D.C. Law 2-58; D.C. Code, sec. 47-3206) is amended to
read as follows:

"Sec. 106. An amount equal to forty percent (40%) of the amount received from the tax imposed by this Title shall be set aside and dispersed to the Washington Convention Center Enterprise Fund for the purpose of promoting Washington Convention Center activities and promoting conventions and tourism in the District of Columbia. The amount set aside and dispersed to the Washington Convention Center Fund shall be further allocated and distributed as follows:

- "(1) fifty percent (50%) to the Washington Convention and Visitors Association:
- "(2) thirty-seven and one-half percent (37.5%) to the Mayor's Committee to Promote Washington; and
- "(3) twelve and one-half percent (12.5%) to the Washington Convention Center for advertising and promotion.".
- Sec. 5. Title I of the Hotel Occupancy and Surtax on Corporations and Unincorporated Business Tax Act of 1977, effective March 16, 1978 (D.C. Law 2-58; D.C. Code, sec. 47-3201 et seq.) is amended by adding a new section 107 at the end thereof to read as follows:

"Sec. 107. The Mayor shall issue rules necessary to carry out the provisions of this act.".

- Sec. 6. (a) Except as provided in subsection (b), this act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
- (b) The provisions of this act shall take effect on the first day of the first month which begins more than 30 days after the effective date of this act, or
