Register, (Vol. 30 page 57) and transmitted to Congress on January 7, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-196, effective March 10, 1983.

D.C. ACT 4 - 280

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC 28 1982

To amend the Rental Housing Conversion and Sale Act of 1980 to expand housing assistance payments and to expand the authorized use of the housing assistance fund.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Rental Housing Conversion and Sale Act of 1980 Amendment Act of 1982".

Sec. 2. Section 307(b) of the Rental Housing

Conversion and Sale Act of 1980, effective September 10,

1980 (D.C. Law 3-86; D.C. Code, sec. 45-1626(b)) is amended
to read as follows:

- "(b) The Mayor may spend revenues from the special fund for providing housing assistance payments as required by this act, and for other purposes as authorized by act of the Council of the District of Columbia.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code,
