"Credit Union Life Insurance Ceiling Amendment Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-291 on first and second readings, September 15, 1981 and September 29, 1981, respectively. Following the signature of the Mayor on October 19, 1981, this legislation was assigned Act No. 4-96, published in the October 30, 1981 edition of the D.C. Register, (Vol. 28 page 4649) and transmitted to Congress on October 23, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-55, effective December 10, 1981.

To amend the ceiling on life insurance on the lives of members of credit unions.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Credit Union Life

Insurance Ceiling Amendment Act of 1981".

Code,
