"Property Tax Relief Application Deadline Extension and Arts and Aging Clarifying Amendments Act of 1981".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 4-318 on first and second readings, October 27, 1981 and November 10, 1981, respectively. Following the signature of the Mayor on December 2, 1981, this legislation was assigned Act No. 4-120, published in the December 11, 1981 edition of the D.C. Register, (Vol. 28 page 5276) and transmitted to Congress on December 11, 1981 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 4-73, effective March 10, 1982.

If such application is filed with Department in person, the real property owner so filing all be given a receipt for the application. In the case of real property owners who take vantage of the extended filing period provided for in ction 2 for the tax year beginning July 1, 1981, and ding June 30, 1982, the appropriate adjustments to real operty tax liabilities shall be reflected in-the cond-half tax bills which are due and payable before April 1982. No adjustment shall be made to first-half tax lls which are already issued and which were due and yable by September 15, 1981.
