"District of Columbia Criminal Justice Act Amendments Act of 1983".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 5-128 on first and second readings, September 20, 1983 and October 4, 1983, respectively. Following the signature of the Mayor on October 11, 1983, this legislation was assigned Act No. 5-69, published in the October 21, 1983 edition of the D.C. Register, (Vol. 30 page 5411) and transmitted to Congress October 14, 1983 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 5-44, effective January 31, 1984.

To amend provisions of the D.C. Code to provide a fair compensation level for attorneys appointed by the court, to increase the compensation for services obtained by court-appointed attorneys, and to improve the quality of legal representation of indigents; and for other purposes.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "District of Columbia
Criminal Justice Act Amendments Act of 1983".

Sec. 2. D.C. Code, sec. 11-2604 is amended as follows:

D.C. Code, sec. 11-2604 (1981 ed.)

- (a) Subsection (a) is amended by striking the phrase "hourly scale established by the provisions of section 3006A(d)(2) of title 18, United States Code" and inserting the phrase "rate of \$35 per hour" in lieu thereof.
- (b) Subsection (b) is amended by striking the phrase "the maximum amounts established by section 3006A(d)(2) of title 18, United States Code, in the corresponding kind of case or proceeding" and inserting the phrase "the following maximum amounts:
 - "(1) \$900 for misdemeanor cases;
 - "(2) \$1700 for felony cases; and
 - "(3) \$900 for post-trial matters if the underlying case was a misdemeanor or \$1700 for post-trial matters if the underlying case was a

felony." in lieu thereof.

Sec. 3. D.C. Code, sec. 11-2605 is amended as follows:

D.C. Code, sec. 11-2605 (1981 ed.)

- (a) Subsection (b) is amended by striking the phrase "\$150" and inserting the phrase "\$375" in lieu thereof.
- (b) Subsection (c) is amended by striking the phrase "\$300" and inserting the phrase "\$750" in lieu thereof.

Sec. 4. Applicability Date and Effective Date.

(a) This act shall apply to services rendered as a result of court appointments made after the effective date of this act.

(b) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
