"Foster Care Goals Act Amendment Act of 1985".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-239 on first and second readings, January 14, 1986, and January 28, 1986, respectively. This legislation was deemed approved without the signature of the Mayor on February 14, 1986, pursuant to Section 404(e) of "the Act", and was assigned Act No. 6-133, published in the February 28, 1986, edition of the D.C. Register, (Vol. 33 page 1160) and transmitted to Congress on February 19, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-104, effective April 11, 1986.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To establish goals and reporting requirements regarding children in foster care for more than two years for the fiscal years ending September 30, 1986 and September 30, 1987 and to require annual administrative reviews.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Foster Care Goals Act
Amendment Act of 1985".

- Sec. 2. Section 2 of the Foster Care Goals Act
 Amendments Act of 1983, effective October 8, 1983 (D.C. Law
 5-30; D.C. Code, sec. 3-114.1), is amended as follows:
 - (a) Subsection (a) is amended as follows:
 - (1) By striking in paragraph (1) the word "and";
- (2) By striking the period in paragraph (2) and inserting a semicolon in its place.
- (3) By adding a new paragraph (3) and (4) to read as follows:
- "(3) Not more than 1,113 children as of September 30, 1986; and
 - "(4) Not more than 920 children as of September

30, 1987.".

(b) Subsection (b)(2) is amended to read as follows:

"Conduct permanency planning for all children in foster care, including an annual administrative review for each child.".

- (c) Subsection (c) is amended by striking the phrase "During the fiscal year ending September 30, 1985" and inserting in its place "During the fiscal years ending September 30, 1985, September 30, 1986, and September 30, 1987".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of a veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973, (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
