
NOTICE

D.C. LAW 6-130

"Wholesale Liquor Industry Storage Act  
of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-329 on first, amended first and second readings, April 15, 1986, April 29, 1986 and May 13, 1986, respectively. Following the signature of the Mayor on May 29, 1986, this legislation was assigned Act No. 6-168, published in the June 6, 1986, edition of the D.C. Register, (Vol. 33 page 3405) and transmitted to Congress on June 2, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-130, effective July 26, 1986.

AN ACT

D.C. ACT 6 - 168

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAY 29 1986

To require the holders of alcoholic beverage licenses to store alcoholic beverages in the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Wholesale Liquor Industry Storage Act of 1986".

Sec. 2. Section 13 of the District of Columbia Alcoholic Beverage Control Act, approved January 24, 1934 (48 Stat. 327; D.C. Code, sec. 25-114), is amended by inserting the sentence "No licensee may store beverages upon premises outside the District of Columbia." after the words "designated in the license."



Sec. 3. The requirements of this act shall not apply to licensed wholesalers permitted by the Alcoholic Beverage Control Board to store beverages outside the District of Columbia as of January 1, 1986, for a period of 2 years following the effective date of this act.



Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the

Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 502(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
