### D.C. LAW 6-131

"D.C. General Hospital Commission Act Temporary Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-446 on first and second readings, April 29, 1986 and May 13, 1986, respectively. Following the signature of the Mayor on May 29, 1986, this legislation was assigned Act No. 6-169, published in the June 6, 1986, edition of the <u>D.C. Register</u>, (Vol. 33 page 3407) and transmitted to Congress on June 2, 1986 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-131, effective July 26, 1986.

## D.C. ACT 6-169

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# MAY 2 9 1986

To amend, on a temporary basis, the D.C. General Hospital Commission Act to authorize the D.C. General Hospital Commission to fix the rates for compensation for D.C. General Hospital's Executive Director and Medical Director and to establish a housing allowance for the Executive Director.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "D.C. General Hospital
Commission Act Temporary Amendment Act of 1986".

Sec. 2. Section 210(14) of the D.C. General Hospital Commission Act, effective May 13, 1977 (D.C. Law 1-134; D.C. Code, sec. 32-220(14)), is amended to read as follows:

D.C. Code sec. 32-21 (1987 supt

"(14)(A) To select an Executive Director and a Medical Director for D.C. General Hospital, establish the division of responsibility between the Executive Director and the Medical Director, and fix the rates of compensation for the Executive Director and the Medical Director, which shall not exceed the rates of compensation for the Mayor of the District of Columbia under section 1109 of the District of Columbia Government Comprehensive Merit Personnel Act of

1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-612.9). The Commission may also establish a housing allowance for the Executive Director.

"(B) Pursuant to subparagraph (A) of this paragraph, the Commission shall develop proposed guidelines on the establishment of a housing allowance that at a minimum: (i) define the term housing allowance; (ii) establish criteria for the negotiation of housing allowances; and (iii) specify what such an allowance entails, i.e. rent subsidy, utility payments, domestic help, etc. These proposed guidelines shall come before the Council of the District of Columbia ("Council") for a 30-day period of review, excluding Saturdays, Sundays, holidays, and days of Council recess. If the Council does not disapprove the proposed guidelines, by resolution, within this 30-day review period, the proposed guidelines shall be deemed approved.".

Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 180th day of its having taken effect.
