D.C. LAW 6-206

"Cable Television Communications Act of 1981 Amendment Act of 1986".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 6-519 on first and second readings, November 18, 1986 and December 16, 1986, respectively. Following the signature of the Mayor on January 8, 1987, this legislation was assigned Act No. 6-266, published in the January 30, 1987, edition of the D.C. Register, (Vol. 34 page 675) and transmitted to Congress on January 13, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 6-206, effective February 28, 1987.

## B.C. ACT 6 - 266

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## JAN 08 1987

To amend the Cable Television Communications Act of 1981 to clarify that the District of Columbia Cable Television Franchisee, District Cablevision Limited Partnership, shall not be required to obtain or to pay for a permit to connect a drop line to the premises of a cable television subscriber or to install cable television equipment and facilities on the premises of a cable television subscriber.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
That this act may be cited as the "Cable Television
Communications Act of 1981 Amendment Act of 1986".

- Sec. 2. Section 34 of the Cable Television

  Communications Act of 1981, effective August 21, 1982 (D.C.

  Law 4-142; D.C. Code, sec. 43-1833), is amended by adding a

  new subsection (j) to read as follows:
- "(j) The franchisee shall not be required to obtain or pay for any permit in order to connect a drop line from trunk or feeder cable of the cable television residential or institutional network systems to the premises of a subscriber or in order to install, maintain, or repair cable television equipment and facilities on the premises of a

subscriber.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
