"District of Columbia Guardianship and Protective Proceedings Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-199 on first and second readings, May 5, 1987, and May 19, 1987, respectively. Following the signature of the Mayor on June 1, 1987, this legislation was assigned Act 7-31, published in the June 12, 1987, edition of the <u>D.C. Register</u>, (Vol. 34 page 3802) and transmitted to Congress on June 10, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-17, effective July 25, 1987.

To amend the District of Columbia Guardianship, Protective Proceedings, and Durable Power of Attorney Act of 1986 to delay the effective date of the guardianship and protective proceedings provisions.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Guardianship and Protective Proceedings Amendment Act of 1987".

Sec. 2. The District of Columbia Guardianship, Protective Proceedings, and Durable Power of Attorney Act of 1986, effective February 28, 1987 (D.C. Law 6-204; D.C. Code, sec. 21-2001 et seg.), is amended as follows:

(a) Section 21-2060(a) of section 2(a) (D.C. Code,

sec. 21-2060(a)) is amended as follows:

(1) By inserting the phrase "protective proceeding, or" after the phrase "quardianship proceeding or,":

(2) By changing the phrase "guardianship

proceeding or" to "quardianship proceeding,":

- (3) By deleting the period after the word "ward" and inserting in its place the phrase "from the estate of the ward, but only as approved by order of the court."; and (4) By deleting in the third sentence the phrase "and reimbursement".
- (b) Section 4(b) (D.C. Code, sec. 21-2001 et sea., note), is amended by the striking the phrase "90 days after the effective date of this act" and inserting in its place the phrase "January 1, 1988".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia
