D.C. LAW 7-20

"District of Columbia Health Occupations Revision Act of 1985 Temporary Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-210 on first and second readings, May 5, 1987, and May 19. 1987, respectively. Following the signature of the Mayor on June 1, 1987, this legislation was assigned Act 7-34, published in the June 12, 1987, edition of the D.C. Register, (Vol. 34 page 3814) and transmitted to Congress on June 10, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-20, effective July 25, 1987.

## D.C. ACT 7 - 34

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## JUN 0 1 1987

To amend, on a temporary basis, the District of Columbia Health Occupations Revision Act of 1985 to extend the time during which the Board of Social Work shall accept applications from practicing social workers for waiver of educational and examination licensing requirements and to extend the time during which the Board of Dietetics and Nutrition shall accept applications from practicing dieticians and nutritionists for waiver of examination requirements.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Health Occupations Revision Act of 1985 Temporary Amendment Act of 1987".

- Sec. 2. The District of Columbia Health Occupations Revision Act of 1985, effective March 25, 1986 (D.C. Law 6-99; D.C. Code, sec. 2-3301.1 et seq.), is amended as follows:
- (a) Section 702 (D.C. Code, sec. 2-3307.2) is amended by deleting the number "12" and inserting in its place the number "24".
- (b) Section 806 (D.C. Code, sec. 2-3308.6) is amended: (1) By amending subsection (a) by deleting the number "12" the second time it appears and inserting in its place the number "24"; and

(2) By amending subsection (b) by deleting the number "12" and inserting in its place the number "24".

Sec. 3.(a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

(b) This act shall expire on the 225th day of its having taken effect.
