"Boards and Commissions Amendment Act of 1987".

pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, \*the Act\*, the Council of the District of Columbia adopted Bill No. 7-139 on first and second readings, April 14, 1987, and May 5, 1987, respectively. Following the signature of the Mayor on June 1, 1987, this legislation was assigned Act 7-26, published in the June 12, 1987, edition of the <u>D.C. Register</u>, (Vol. 34 page 3789) and transmitted to Congress on June 10, 1987 for a 60-day review, in accordance with Section 602(c)(2) of the Act.

The Council of the District of Columbia hereby gives notice that the 60-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-31, effective October 7, 1987.

# D.C. ACT 7 - 26

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## JUN 0 1 1987

To amend the District of Columbia Procurement Practices Act of 1985, the District of Columbia Health Occupations Revision Act of 1985, the Rental Housing Act of 1985, the Litter and Solid Waste Act of 1985, the Authorization for the Establishment of a Public School of Law for the District of Columbia Amendment Act of 1986, and the District of Columbia Taxicab Commission Establishment Act of 1985 to comply with the policy of requiring member term dates to begin on the date that a majority of the initial members were sworn in; to amend the Hazardous Materials Study Commission Act of 1986 to allow nonresidents of the District of Columbia to serve as commission members; and to amend section 23-1304 of the District of Columbia Code to provide a term for Mayoral appointments to the executive committee of the District of Columbia Pretrial Services Agency.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Boards and Commissions Amendment Act of 1987".

Sec. 2. Section 902(a)(1) of the District of Columbia Procurement Practices Act of 1985, effective February 21, 1986 (D.C. Law 6-85; D.C. Code, sec. 1-1189.2(a)(1)), is amended by adding the following sentence after the first sentence:

"The terms of the chairperson and members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.".

Sec. 3. The District of Columbia Health Occupations Revision Act of 1985, effective March 25, 1986 (D.C. Law 6-99; D.C. Code, sec. 2-3301.1 et seq.), is amended as follows:

(a) Section 201(e) (D.C. Code, sec. 2-3302.1(e)) is D.C. Code, sec. 2-3301. amended by adding the following sentence at the end of the (1988 supp.) subsection: "The terms of the members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.". (b) Section 203(a)(6) (D.C. Code, sec. 2-3302.3 D.C. Code, (a)(6)) is amended by adding the following sentence at the sec. 2-3302. (1988 supp.) end of the subsection: "The terms of the members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.". D.C. Code, (c) Section 204(e) (D.C. Code, sec. 2-3302.4(e)) is sec. 2-3302. amended by adding the following sentence at the end of the (1988 supp.) subsection: "The terms of the members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.". (d) Section 205(e) (D.C. Code, sec. 2-3302.5(e)) is amended by adding the following sentence at the end of the D.C. Code. sec. 2-3302.5 subsection: (1988 supp.) "The terms of the members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.". (f) Section 212(e) (D.C. Code, sec. 2-3302.12(e)) is D.C. Code, sec. 2-3302.1 amended by adding the following sentence at the end of the (1988 supp.) subsection:

"The terms of the members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.".

Sec. 4. Section 201(a) of the Rental Housing Act of 1985, effective July 17, 1985 (D.C. Law 6-10; D.C. Code, sec. 45-2511(a)), is amended by adding the following sentence at the end of the subsection:

"The date of swearing in for a majority of the members of the Rental Housing Commission appointed pursuant to this

D.C. Code, sec. 45-2511 (1988 supp.) section shall become the anniversary date for all subsequent appointments.".

Sec. 5. Section 2(e) of the Litter and Solid Waste Act D.C. Code, of 1985, effective February 21, 1986 (D.C. Law 6-84; D.C. Code, sec. 2-3201(e)), is amended by adding a new paragraph (3) to read as follows:

- "(3) The terms of the members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.".
- Section 504(d) of the Authorization for the Establishment of a Public School of Law for the District of Columbia Amendment Act of 1986, effective February 24, 1987 (D.C. Law 6-177; to be codified at D.C. Code, sec. 31-1544(d)), is amended by adding the following sentence at the end of the subsection:

D.C. Code, sec. 31-15 (1988 supp

"The term of the members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.".

Sec. 7. Section 6(b) of the District of Columbia Taxicab Commission Establishment Act of 1985, effective March 25, 1986 (D.C. Law 6-97; D.C. Code, sec. 40-1705(b)), is amended by adding the following sentence at the end of the subsection:

D.C. Code, sec. 40-170 (1988 supp.

"Except for the Chairperson, the terms of all members first appointed shall begin on the date that a majority of the first members are sworn in, which shall become the anniversary date for all subsequent appointments.".

Sec. 8. Section 4(a) of the Hazardous Materials Study Commission Act of 1986, effective June 25, 1986 (D.C. Law 6-123; to be codified at D.C. Code, sec. 6-2403(a)), is amended by adding a new paragraph (5) to read as follows:

D.C. Code,

sec. 23-130 (1988 supp.

- "(5) Members of the commission may be residents or nonresidents of the District of Columbia.".
- Sec. 9. Section 23-1304(a) of the District of Columbia Code is amended by adding the following sentence at the end of the subsection:

"Each member appointed by the Mayor shall serve for a 3-year term, which shall begin on the date that a majority of these members are sworn in. This date shall be the anniversary date for all subsequent Mayoral appointments.".

Sec. 10. This act shall take effect after a 60-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(2) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(2)).
