D.C. LAW 7-32

"Nurses Training Corps Establishment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-146 on first and second readings, June 16, 1987, and June 30, 1987, respectively. Following the signature of the Mayor on July 23, 1987, this legislation was assigned Act 7-60, published in the August 14, 1987, edition of the <u>D.C. Register</u>, (Vol. 34 page 5312) and transmitted to Congress on July 29, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-32, effective October 9, 1987.

# D.C. ACT 7 - 60

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

Codification, New Chapter 26 of Title 31

## JUL 2 3 1987

To increase the availability of trained nurses at D.C.

General Hospital through the establishment of a nurses training corps.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Nurses Training Corps Establishment Act of 1987".

Sec. 2. (a) There shall be established in the District of Columbia ("District") a Nurses Training Corps ("Corps"), which shall provide financial aid to District residents desiring to obtain a Licensed Practical Nurse ("LPN") certificate or an Associate of Arts degree or a Bachelor of Science degree in nursing.

- (b) The financial aid provided by the Corps shall include tuition and may include the following:
- The reasonable cost of textbooks and supplies;
- (2) The reasonable transportation costs to and from classes;
- (3) The reasonable cost of child care while attending classes; and

(4) A stipend to help defray the cost of reasonable living expenses for full-time enrolled students.

- (c) In exchange for financial aid, the student shall contract to work for D.C. General Hospital or the Department of Human Services for a specified number of years after completion of the agreed nursing education.
- (d) The basic criteria for selection to the Corps shall include the following:
- Bona fide residency in the District for 2 years immediately prior to application to the Corps;
- (2) Stated interest in nursing and public service in the field of nursing within the District;
  - (3) Financial need; and

- (4) Admission to an accredited program of nursing study within the District.
- Sec. 3. The Department of Human Services shall be responsible for the administration of the Corps.

Sec. 4. Within 120 days of the effective date of this act, the Mayor shall, pursuant to title I of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1204; D.C. Code, sec. 1-1501 et seq.), issue proposed rules to implement the provisions of this act. The proposed rules shall be submitted to the Council for a 45-day period of review, excluding Saturdays, Sundays, legal holidays, and days of Council recess. If the Council does not approve or disapprove the proposed rules, in whole or in part, by resolution within this 45-day review period, the proposed rules shall be deemed approved. The proposed rules shall include provisions regarding the terms of the employment contracts, including the period of service required.

Sec. 5. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of a veto by the Mayor, action by the Council to override the veto), as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
