"Citizens Energy Advisory Committee Extension Amendment Temporary Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-144 on first and second readings, March 3, 1987 and March 17, 1987, respectively. Following the signature of the Mayor on March 25, 1987, this legislation was assigned Act No. 7-13, published in the April 10, 1987, edition of the D.C. Register, (Vol. 34 page 2334) and transmitted to Congress on March 30, 1987 for a 30-day review, in accordance with Section 602 (c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-4, effective May 19, 1987.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAR 2 5 1987

To amend, on a temporary basis, the District of Columbia Office of Energy Act of 1980 to extend the life of the Citizens Energy Advisory Committee and to make a technical and clarifying amendment.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,

That this act may be cited as the "Citizens Energy Advisory

Committee Extension Amendment Temporary Act of 1987".

Sec. 2. Section 7 of the District of Columbia Office of Energy Act of 1980, effective March 4, 1981 (D.C. Law 3-132: D.C. Code, sec. 1-1906), is amended as follows:

D.C. Code, sec. 1-1906 (1988 supp.)

- (a) Subsection (d)(1) is amended by striking the phrase "Public Services and Cable Television" and inserting the phrase "Human Services" in its place.
- (b) Subsection (e) is amended by striking the phrase "six (6) years" and inserting the phrase "10 years" in its place.
- Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the

Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 225th day of its having taken effect.
