"District of Columbia Enterprise Zone Study Commission Act of 1986 Amendment Temporary Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act. P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-294 on first and second readings, July 14, 1987, and September 29, 1987, respectively. Following the signature of the Mayor on October 16, 1987, this legislation was assigned Act 7-88, published in the October 30, 1987, edition of the D.C. Register, (Vol. 34 page 6897) and transmitted to Congress on October 21, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-55, effective December 10, 1987.

D.C. ACT 7 - 88

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OST 1 6 1987

To amend, on a temporary basis, the District of Columbia Enterprise Zone Study Commission Act of 1986 to extend the life of that commission.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Enterprise Zone Study Commission Act of 1986 Amendment Temporary Act of 1987".

Sec. 2. Section 6 of the District of Columbia Enterprise Zone Study Commission Act of 1986, effective February 24, 1987 (D.C. Law 6-171; D.C. Code, sec. 1-2255), (1988 supp.) is amended to read as follows:

D.C. Code. sec. 1-2255

"Sec. 6. Commission report.

"The commission shall complete its work and submit its report with recommendations to the Council no later than 12 months following the first meeting of the commission. Upon filing its report, all authority for the commission shall expire.".

Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 225th day of its having taken effect.
