D.C. LAW 7-58

"District of Columbia Ceremonial Funds Amendment Temporary Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-307 on first and second readings, September 29, 1987, and October 13, 1987, respectively. Following the signature of the Mayor on October 26, 1987, this legislation was assigned Act 7-91, published in the November 6, 1987, edition of the D.C. Register, (Vol. 34 page 7083) and transmitted to Congress on October 27, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-58, effective December 16, 1987.

D.C. ACT 7 - 91

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 2 6 1987

To amend, on a temporary basis, An Act to authorize funds for ceremonies in the District of Columbia to provide that ceremonial funds be accounted for and audited in the same manner as other District governmental funds and to authorize the appropriation of not more than \$25,000 annually for these expenses by the Mayor and by the Council.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Ceremonial Funds Amendment Temporary Act of 1987".

Sec. 2. Section 1 of An Act to authorize funds for ceremonies in the District of Columbia, approved July 11, 1947 (61 Stat. 314; D.C. Code, sec. 1-355), is amended to read as follows:

"Sec. 1. (a) There is authorized to be appropriated an amount not to exceed \$25,000 in any fiscal year for expenses as the Mayor of the District of Columbia shall deem to be necessary, including personal services, for the reception and entertainment of officials of foreign, state, local, or federal governments and other dignitaries and eminent persons visiting in or returning to the District of Columbia.

- "(b) There is authorized to be appropriated an amount not to exceed \$25,000 in any fiscal year for expenses as the Council of the District of Columbia shall deem to be necessary, including personal services, for the reception and entertainment of officials of foreign, state, local, or federal governments and other dignitaries and eminent persons visiting in or returning to the District of Columbia.
- "(c) Any amounts appropriated for expenses under this section shall be subject to audit and accounted for in the same manner as any other District of Columbia government funds used for governmental purposes.

D.C. Code, sec. 1-355 (1988 supp. "(d) The Secretary of the District of Columbia and the Secretary to the Council of the District of Columbia shall issue annual reports, which shall be made available to the public, on disbursements under this section by the Mayor of the District of Columbia and by the Council of the District of Columbia, respectively. Records of disbursements under this section shall be retained for 5 years.".

Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 225th day of its
