"Extension of the Moratorium on Retail Service Station Conversions Amendment Temporary Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-309 on first and second readings, September 29, 1987, and October 13, 1987, respectively. Following the signature of the Mayor on October 26, 1987, this legislation was assigned Act 7-92, published in the November 6, 1987, edition of the D.C. Register, (Vol. 34 page 7085) and transmitted to Congress on October 27, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-59, effective December 16, 1987.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 2 6 1987

To amend, on a temporary basis, the Retail Service Station Act of 1976 to extend the moratorium on the conversion of full service retail service stations to limited service retail service stations and to extend the life of the Gas Station Advisory Board.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Extension of the Moratorium on Retail Service Station Conversions Amendment Temporary Act of 1987".

Sec. 2. The Retail Service Station Act of 1976, effective April 19, 1977 (D.C. Law 1-123; D.C. Code, sec. 10-231), is amended as follows:

D.C. Code, sec. 10-231 (1988 supp.)

- (a) Subsections (b) and (c) of section 5-301 are amended by striking the phrase "October 1, 1987" and inserting the phrase "October 1, 1991" in its place.
- (b) Subsection (e)(4) of section 5-301 is amended by striking the phrase "October 1, 1987, or when the ceiling established in subsection (d) of this section shall be reached, whichever date occurs first" and inserting the phrase "October 1, 1991" in its place.

Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 225th day of its having taken effect.
