### D.C. LAW 8-118

"Abandoned Property Amendment Act of 1990".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-419 on first and second readings, January 30, 1990, and February 13, 1990, respectively. The legislation was deemed approved without the signature of the Mayor on March 6, 1990, pursuant to Section 404(e) of "the Act", and was assigned Act No. 8-172, published in the March 16, 1990, edition of the <u>D.C. Register</u>, (Vol. 37 page 1736) and transmitted to Congress on March 13, 1990 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-118, effective May 4, 1990.

#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# MAR 06 1990

To amend the Revised Statutes of the District of Columbia to establish an Office of the Property Clerk within the Metropolitan Police District and to require that the office be staffed by civilians and a Property Clerk who is a member of the Metropolitan Police Force.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Abandoned Property Amendment Act of 1990".

Sec. 2. The Revised Statutes of the District of Columbia, approved December 5, 1919 (R.S., D.C. 48; D.C. Code, sec. 4-152 <u>et seq</u>.), are amended as follows:

(a) Section 408 (D.C. Code, sec. 4-152(a)) is amended to read as follows:

"Sec. 408. There shall be an office of the Metropolitan Police District known as the Office of the Property Clerk. The Property Clerk shall be a member of the Metropolitan Police force. The staff shall consist of civilians who are not members of the Metropolitan Police force, except that police officers may provide security for lost, stolen, or abandoned property held by the office.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Section 4-152

Statutes-at-Large, or the District of Columbia Municipal Regulations.
