### D.C. ACT 8 - 179

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

### MAR 15 1990

To amend Title 16 of the District of Columbia Code to require a person to submit to a genetic test if requested by a party and to clarify that a genetic test must be admitted into evidence even if a party objects to the introduction, unless the objection is a substantial one.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Genetic Tests for the Establishment of Paternity Amendment Act of 1990".

- Sec. 2. Title 16 of the District of Columbia Code is amended as follows:
- (a) Section 16-2343(a)(1) is amended by striking the phrase "or on the motion of a party, may require" and inserting the phrase", may require, or on the motion of a party, shall require" in its place; and

(b) Section 16-2343.1(a) is amended as follows:

- (1) Paragraph (1) is amended by striking the phrase "Test results or expert reports showing" and inserting the phrase "Expert reports that show" in its place; and
- (2) A new paragraph (3) is added to read as follows:
- "(3) Test results that show the statistical probability of the alleged parent's paternity shall be admitted into evidence unless a substantiated objection is made that the test did not comply with the requirements of this subchapter.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
