D.C. ACT 8 - 215

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUN 14 1990

To amend the District of Columbia Solid Waste Management and Multi-Material Recycling Act of 1988 to clarify that owners and occupants of commercial property are responsible for recycling, require the Director of the Department of Public Works to enter into contracts or agreements to market recyclable materials, and clarify licensure authority under the act.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Recycling Clarification Amendment Act of 1990".

Sec. 2. The District of Columbia Solid Waste Management and Multi-Material Recycling Act of 1988, effective March 16, 1989 (D.C. Law 7-226; D.C. Code, sec. 6-3401 et seq.) ("Recycling Act"), is amended as follows:

(a) Section 4(19) (D.C. Code, sec. 6-3403(19)) is amended by adding the phrase "majority of owners or" after the phrase "if the".

(b) Sections 8(a) and (b) (D.C. Code, sec. 6-3407(a) and (b)) are amended by adding the phrase "owners and" before the word "occupants" wherever it appears.

(c) Section 9(b) (D.C. Code, sec. 6-3408(b)) is amended by adding a new paragraph (13) to read as follows:
"(13) License businesses and vehicles to engage

in the collection or transportation of recyclable materials as required by this act or by rules issued pursuant to section 20 of this act.".

(d) Section 12 (D.C. Code, sec. 6-3411) is amended by adding a new sentence to the end to read as follows:

"The Director of the Department of Public Works shall enter into contracts or agreements to market recyclable materials, including the sale or disposition of recyclable materials, and shall purchase or lease any equipment necessary to facilitate the marketing of recyclable materials.".

This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
