### D.C. LAW 8-157

"Preventive Health Services Amendment Act of 1990".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-385 on first and second readings, May 29, 1990, and June 12, 1990, respectively. Following the signature of the Mayor on June 18, 1990, this legislation was assigned Act No. 8-219, published in the June 29, 1990, edition of the <u>D.C. Register</u>, (Vol. 37 page 4165) and transmitted to Congress on June 21, 1990 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-157, effective September 11, 1990.

# D.C. ACT 8 - 219

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# JUN 18 1990

To permit the Commissioner of Public Health to exchange identifying cancer information to a registry maintained by a state in order to foster effective cancer research, prevention, and control efforts.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Preventive Health Services Amendment Act of 1990".

Sec. 2. Section 2 of An Act to make cancer and all malignant neoplastic diseases reportable to the Director of Public Health of the District of Columbia, approved July 27, 1951 (65 Stat. 124; D.C. Code, sec. 6-1202), is amended to read as follows:

Section 6-1202

- (a) By amending subsection (b)(1) by striking the 2nd "or";
- (b) By amending subsection (b)(2) by striking the period at the end and inserting "; or" in its place; and
- (c) By adding a new subsection (3) to read as follows:
   "(3) The identifying information is exchanged
  with a cancer registry that is maintained by a state and the
  Commissioner of Public Health receives a satisfactory
  assurance from the cancer registry that the confidentiality
  of the identifying information shall be preserved.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and
