AN ACT

D.C. ACT 8-308

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC. 27, 1990

To provide insurance coverage for mammography examinations and cytologic screening.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Cancer Prevention Act of 1990".

Sec. 2. Definitions.

section 35-2401

For the purposes of this act, the term:

- (1) "Baseline mammogram" means a screening mammogram that is used as a comparison for future examinations;
- (2) "Screening mammogram" means a low dose x-ray used to visualize the internal structure of the breast;
- (3) "Cytologic screening" means a pap test to detect cervical cancer through the simple microscopic examination of cells scraped from the surface of the cervix.
- (4) "Health insurance policy" means any health insurance policy that provides for the payment of indemnity on account of sickness and is offered by Group Hospitalization and Medical Service Incorporated, a health insurance company, a health self insured, an insurance purchasing trust, or any health maintenance organization that offers insurance benefits or health plans in the District of Columbia ("District"). The term "health insurance policy" shall not include a hospital indemnity policy, a disability insurance policy, an accident only policy, or a student accident policy.
  - Sec. 3. Payable Benefits.

New

- (a) Any individual or group health insurance policy or section service, including Medicaid, shall provide health insurance 35-2402 benefits to cover:
  - (1) A baseline mammogram for women; and
  - (2) An annual screening mammogram for women.

- (b) Any individual or group health insurance policy or service, including medicaid, shall provide health insurance benefits to cover:
- (1) Annual cervical cytologic screening for women; and
- (2) Cervical cytologic screening for women upon certification by an attending physician that the test is medically necessary.
- (c) Benefits provided in accordance with this section shall not be subject to an annual or coinsurance deductible.

Sec. 4. Applicability.

The requirements of this act shall apply:

New section 35-2403

- (1) To any insurance policy or subscriber contract delivered or issued for delivery in the District more than 120 days after the effective date of this act; and
- (2) To any insurance policy or subscriber contract renewed, amended, or reissued 120 days after the effective date of this act.
- Sec. 5. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
