### D.C. ACT 8-310

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

### DEC. 27, 1990

To amend An Act To grant additional powers to the Commissioners of the District of Columbia, and for other purposes, to authorize the Mayor to sell government publications.

BF IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Sale of Government Publications Amendment Act of 1990".

Sec. 2. Section (i)(1) of An Act To grant additional powers to the Commissioners of the District of Columbia, and for other purposes, approved December 20, 1944 (58 Stat. 819; D.C. Code, sec. 1-337(i)(1)), is amended to read as follows:

Section 1-337

- "(i) Purchase and sale of maps and publications; issuance without charge; delegation of authority; payment of cost. -- The Mayor of the District of Columbia is authorized and empowered within his or her discretion:
- "(1) To purchase and sell maps and to sell copies and subscriptions of the District of Columbia
  Statutes-at-Large, the District of Columbia Register, the District of Columbia Municipal Regulations, other government publications, and other data and information ("government materials"), including binders for material, at prices the Mayor or his or her designated agent determines to be necessary to approximate the cost of the material, including the cost of distribution. The Mayor shall not charge the Council of the District of Columbia for copies or subscriptions of government materials or any other rule, regulation, or document that has general applicability and legal effect which the Council needs to perform its legislative responsibilities. All receipts from the sale of such material shall be deposited in the General Fund;".
- Sec. 3. Section 4 of the Omnibus Narcotic and Abusive Drug Interdiction Amendment Act of 1990, effective June 13,

Section 33-565

1990 (D.C. Law 8-138; D.C. Code, sec. 33-565(e)), is amended by striking the phrase "(52 Stat. 793; D.C. Code, sec. 33-556(e))" and inserting the phrase "(52 Stat. 793; D.C. Code, sec. 33-565(e))" in its place.

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Pegister, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Pegulations.
