D.C. LAW 8-245

"Good Faith Donor and Donee Act of 1981 Amendment Act of 1990".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-550 on first and second readings, December 4, 1990, and December 18, 1990, respectively. Following the signature of the Mayor on December 27, 1990, this legislation was assigned Act No. 8-328, published in the January 11, 1991, edition of the <u>D.C. Register</u>, (Vol. 38 page 367) and transmitted to Congress on January 15, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-245, effective March 8, 1991.

AN ACT

D.C. ACT 8-328

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC. 27, 1990

To amend the Good Faith Donor and Donee Act of 1981 to further facilitate the donation of food products to needy persons in the District.

PE IT FNACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Good Faith Donor and Donee Act of 1981 Amendment Act of 1990".

Sec. 2. Section 2 of the Good Faith Donor and Donee Act of 1981, effective October 8, 1981 (D.C. Law 4-39; D.C. Code, sec. 33-801), is amended by striking the phrase ", recklessness," wherever it appears.

Section 33-801

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Covernment and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Pegister, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal Pegulations.
