D.C. LAW 8-259

"Board of Trustees of the University of the District of Columbia Compensation Amendment Temporary Act of 1990".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-734 on first and second readings, December 18, 1990, and February 5, 1991, respectively. Following the signature of the Mayor on February 15, 1991, this legislation was assigned Act No. 8-344, published in the March 8, 1991, edition of the <u>D.C. Register</u>, (Vol. 38 page 1449) and transmitted to Congress on February 22, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-259, effective April 20, 1991.

Codification, District of Columbia Code (1991 Supplement)

AN ACT

D.C. ACT 8-344

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

FEBRUARY 15, 1991

To amend, on a temporary basis, the District of Columbia Public Postsecondary Education Reorganization Act to provide that members of the Board of Trustees of the University of the District of Columbia may receive only reimbursement for expenses incurred while engaged in service as Trustees.

BF IT FNACTFD BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Board of Trustees of the University of the District of Columbia Compensation Amendment Temporary Act of 1990".

Sec. 2. Section 204 of the District of Columbia Public Postsecondary Education Reorganization Act, approved October 26, 1974 (88 Stat. 1426; D.C. Code, sec. 31-1514), is amended by striking the existing language in its entirety and adding the following language in its place:

"Reimbursement of Trustees.

Trustees shall serve without compensation except that each Trustee shall be entitled to reimbursement for actual and necessary expenses incurred while actually engaged in service as a Trustee, provided that these expenses are properly documented. In no case, however, shall a Trustee receive expense reimbursement that exceeds \$4,000 per annum.".

Sec. 3.(a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Note, Section
