### D.C. LAW 8-34

"Guardianship, Protective Proceedings, and Durable Power of Attorney Revision Amendment Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-226 on first and second readings, June 13, 1989, and June 27, 1989, respectively. Following the signature of the Mayor on July 7, 1989, this legislation was assigned Act No. 8-59, published in the July 21, 1989, edition of the <u>D.C. Register</u>, (Vol. 36 page 5035) and transmitted to Congress on July 12, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-34, effective September 22, 1989.

## D.C. ACT 8 - 59

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

### JUL 0 7 1989

To amend the District of Columbia Guardianship, Protective Proceedings, and Durable Power of Attorney Act of 1986 to delay the effective date of the guardianship and protective proceedings provisions of the act, to delete the jury trial provisions, to allow the court to waive the appointment of visitors and examiners, and to provide for additional time for service by mail.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Guardianship, Protective Proceedings, and Durable Power of Attorney Revision Amendment Act of 1989".

Sec. 2. The District of Columbia Guardianship, Protective Proceedings, and Durable Power of Attorney Act of 1986, effective February 28, 1987 (D.C. Law 6-204; D.C. Code, sec. 21-2001 et seq.), is amended as follows:
(a) By amending section 4(b) by striking the date

"January 1, 1988" and inserting in its place the date "September 30, 1989";

(b) By amending section 21-2002(c) to read as follows: "(c) Nothing in this chapter shall affect any guardian or conservator appointed by the court upon a petition filed prior to the effective date of this chapter.";

(c) By amending the table of contents for Chapter 20 by striking the phrase "21-2023. Jury trial.";

(d) By repealing section 21-2023;

(e) By amending section 21-2031(b)(1) by striking the number "14" and inserting the number "17" in its place; (f) By amending section 21-2041(d) by adding a new

sentence to the end to read as follows:

"The court may waive the appointment of a visitor and, where a report has been submitted in writing to the court for the allegedly incapacitated individual, the court may waive the appointment of an examiner.":

(g) By amending section 21-2041(h) to read as follows:
