IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend the District of Columbia Business Corporation Act to provide a uniform annual report fee requirement for foreign and domestic corporations.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Business Corporation Act Amendment Act of 1989".

Sec. 2. Section 121 of the District of Columbia Business Corporation Act, approved June 8, 1954 (68 Stat. 228; D.C. Code, sec. 29-399.22), is amended as follows:

Section 29-399.22

- (a) By amending subsections (d) and (e) to read as follows:
- "(d) Each foreign or domestic corporation authorized to do business in the District of Columbia or organized, incorporated, or reincorporated under the provisions of this act shall pay an annual report fee of \$100.00, which shall be paid at the time that the annual report, which is required of corporations under the provisions of this chapter, is filed. The provisions of this subsection shall apply to each annual report fee due and payable on April 15, 1989, and each following April 15th.

"(e) If the annual report fee of a domestic corporation is unpaid at the time that it is due, interest shall accrue on the annual report fee at the rate of 5% per month until the report fee is paid.".

- (b) By striking subsections (f) and (g).
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of

Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
