DC ACT 8-102

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 2 7 1989

To amend, on a temporary basis, the District of Columbia Public Assistance Act of 1982 to conform to the requirements of the Family Support Act of 1988.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Public Assistance Act of 1982 Conforming Amendments Amendment Temporary Act of 1989".

- Sec. 2. Title V of the District of Columbia Public Assistance Act of 1982, effective April 6, 1982 (D.C. Law 4-101; D.C. Code, sec. 3-205.1 et seq.), is amended as follows:
- (a) The second sentence of section 505(1) (D.C. Code, sec. 3-205.5(1) is amended by inserting the word "not" between the words "shall" and "include".
- (b) Section 511 (D.C. Code, sec. 3-205.11) is amended as follows:
- (1) By amending subsection (a) as follows:
 (A) By amending paragraph (1) by striking the number "\$75" and inserting the number "\$90" in its place.
- (B) By amending paragraph (2) as follows:

 (i) By striking the phrase "\$160 per month per child" and inserting the phrase "\$175 per month per child for a child under 2 years of age" in its place; and
- (ii) By striking the phrase "a maximum of \$120 if the individual has worked less than 120 hours in the month" and inserting the phrase "a maximum of \$200 per month per child for a child under 2 years of age" in its place;
- (2) By amending the 1st sentence of paragraph (5) by striking the phrase "not already disregarded" and inserting the following phrase in its place:

Section 3-205.5

Section 3-205.11

"The \$30 plus one-third disregard for individuals found otherwise eligible will be applied before the disregards specified in paragraph (2) of this subsection and after the disregard specified in paragraph (1) of this subsection."; and

(3) By adding a new paragraph (5A) to read as follows:

"(5A) Disregard any Federal Earned Income Tax Credit received.".

Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect.
