
NOTICE

D.C. LAW 8-88

"Housing Production Trust Fund Board  
Amendment Temporary Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-474 on first and second readings, November 21, 1989, and December 5, 1989, respectively. The legislation was deemed approved without the signature of the Mayor on January 3, 1990, pursuant to Section 404(e) of "the Act", and was assigned Act No. 8-139, published in the January 12, 1990, edition of the D.C. Register, (Vol. 37 page 284) and transmitted to Congress on January 23, 1990 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-88, effective March 15, 1990.

AN ACT

D.C. ACT 8 - 189

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JAN - 3 1990

To amend, on a temporary basis, the Housing Production Trust Fund Act of 1988 to require that the non-government members of any Housing Production Trust Fund Board established by the Mayor be appointed by the Mayor with the advice and consent of the Council of the District of Columbia.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, Note,  
That this act may be cited as the "Housing Production Trust Fund Board Amendment Temporary Act of 1989". 1-229


Sec. 2. The Housing Production Trust Fund Act of 1988, effective March 16, 1988 (D.C. Law 7-202; D.C. Code, sec. 45-3101 et seq.), is amended by adding a new section 3a to read as follows: New Section 45-3102.1

"Sec. 3a. Housing Production Trust Fund Board.

"Any non-government member of a Board established by the Mayor to administer or provide advice on the administration of the Housing Production Trust Fund shall be appointed by the Mayor with the advice and consent of the Council of the District of Columbia."

Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect.
