## D.C. LAW 8-89

"District of Columbia Codification Amendment Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-265 on first and second readings, December 5, 1989, and December 19, 1989, respectively. Following the signature of the Mayor on January 8, 1990, this legislation was assigned Act No. 8-140, published in the January 19, 1990, edition of the D.C. Register, (Vol. 37 page 644) and transmitted to Congress on January 23, 1990 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-89, effective March 15, 1990.

# D.C. ACT 8 - 140

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# JAN - 8 1990

To amend the District of Columbia Codification Act of 1975 to exclude from the prior publication requirement any resolution that pertains to the internal operation or organization of the Council.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Codification Amendment Act of 1989".

Sec. 2. Section 204(f) of the District of Columbia Codification Act of 1975, effective October 8, 1975 (D.C. Law 1-19; D.C. Code, sec. 1-1602), is amended to read as follows:

Section 1-1602

- "(f) No act or resolution shall be effective until the act or resolution has been published in the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations, except that any emergency act or resolution, approved pursuant to section 412(a) of the District of Columbia Self-Government and Governmental Reorganization Act of 1973, approved December 24, 1973 (87 Stat. 788; D.C. Code, sec. 1-229(a)), or any resolution that pertains to the internal operation or organization of the Council, shall be effective without prior publication but shall be published as soon as practicable."
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in the either the District of Columbia Register, the District of Columbia
