#### D.C. LAW 8-9

"Fiduciary Investment Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-140 on first and second readings, April 4, 1989, and April 18, 1989, respectively. Following the signature of the Mayor on April 27, 1989, this legislation was assigned Act No. 8-25, published in the May 12, 1989, edition of the <u>D.C. Register</u>, (Vol. 36 page 3361) and transmitted to Congress on May 2, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-9, effective June 16, 1989.

# D.C. ACT 8 - 25

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

### APR 2 7 1989

To amend title 21 of the District of Columbia Code to authorize a fiduciary, acting pursuant to a trust instrument that directs or authorizes investment in obligations of the government of the United States, to invest in the obligations through an investment company registered under the Investment Company Act of 1940, when the portfolio of the investment company is limited to obligations of the government of the United States or repurchase agreements collateralized by obligations of the government of the United States.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Fiduciary Investment Act of 1989".

Sec. 2. Title 21 of the District of Columbia Code is amended as follows: (a) By amending the table of contents for the title by striking the phrase "Uniform Fiduciaries Act...Sections 21-1701 to 21-1712." and inserting the phrase "General Fiduciary Relations.....Sections 21-1701 to 21-1721." in its place. (b) By amending the table of contents for Chapter 17 by: (1) Striking in the Chapter heading the phrase "Uniform Fiduciaries Act" and inserting the phrase "General Fiduciary Relations" in its place; (2) Adding after the Chapter heading the phrase "Subchapter I. Uniform Fiduciaries Act"; and (3) Adding at the end of the table of contents "Subchapter II. General Provisions.": By amending section 21-1712, by striking the word (c) Section "chapter" and inserting the word "subchapter" in its place; 21-1712 and (d) By adding a new section 21-1721 to read as New, Section follows: 21 - 1721

"Section 21-1721. Investment of trust assets.
