"Namibia Sanctions Repeal Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-361 on first and second readings, April 7, 1992, and May 6, 1992, respectively. Following the signature of the Mayor on May 28, 1992, this legislation was assigned Act No. 9-211, published in the June 5, 1992, edition of the <u>D.C. Register</u>, (Vol. 39 page 3828) and transmitted to Congress on May 29, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that then 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-127, effective July 22, 1992.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAY 28, 1992

To amend the District of Columbia Depository Act of 1977, the District of Columbia Housing Finance Agency Act, the District of Columbia Retirement Reform Act, the Prohibition of the Investment of Public Funds in Financial Institutions and Companies Making Loans to or Doing Business with the Republic of South Africa or Namibia Act of 1983, and the District of Columbia Procurement Practices Act of 1985 to remove Namibia from the prohibitions and restrictions imposed by the Prohibition of the Investment of Public Funds in Financial Institutions and Companies Making Loans to or Doing Business with the Republic of South Africa or Namibia Act of 1983 and the South Africa and Namibia Contracting Sanction Amendment Act of 1986.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Namibia Sanctions Repeal Amendment Act of 1992".

This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
