D.C. LAW 9-165

"District of Columbia Health Occupations Revision Act of 1985 Temporary Licensure of Social Workers Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-370 on first and second readings, June 2, 1992, and July 7, 1992, respectively. Following the signature of the Mayor on July 23, 1992, this legislation was assigned Act No. 9-263, published in the August 7, 1992, edition of the <u>D.C. Register</u>, (Vol. 39 page 5817) and transmitted to Congress on July 27, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-165, effective October 1, 1992.

D.C. ACT 9-263 (1993 Supplement)

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 23, 1992

To amend the District of Columbia Health Occupations Revision Act of 1985 to provide for the temporary licensure of social workers for a period not to exceed 1 year.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Health Occupations Revision Act of 1985 Temporary Licensure of Social Workers Amendment Act of 1992".

Sec. 2. Section 302(12) of the District of Columbia Health Occupations Revision Act of 1985, effective March 26, 1986 (D.C. Law 6-99; D.C. Code §2-3303.2) is amended by striking ";" at the end and inserting in its place the phrase ", except the Mayor may provide for the issuance of temporary licenses to applicants for licensure to practice social work for a period not to exceed 1 year.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code 1-233(c)(1), and publication in either the District of Columbia Register, the District of
