Register, (Vol. 39 page 9009) and transmitted to Congress on January 6, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-193, effective March 16, 1993.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOVEMBER 23, 1992

To amend An Act To establish a code of law for the District of Columbia to allow members of fraternal benefit associations to freely designate beneficiaries.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Fraternal Benefit Association Beneficiaries Designation Amendment Act of 1992".

Sec. 2. Section 749 of An Act To establish a code of law for the District of Columbia, approved March 3, 1901 (31 Stat. 1310; D.C. Code § 35-1201), is amended by adding the phrase "any person, organization, or institution designated by the member, including, but not limited to," after the phrase "The payment of death benefits shall be to"."

Sec. 3. Effective date.

This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
