### D.C. LAW 9-194

"District of Columbia Youth Services Act of 1976 Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-450 on first and second readings, October 6, 1992, and November 4, 1992, respectively. Following the signature of the Mayor on November 23, 1992, this legislation was assigned Act No. 9-315, published in the December 4, 1992, edition of the D.C. Register, (Vol. 39 page 9010) and transmitted to Congress on January 6, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-194, effective March 16, 1993.

#### IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## NOVEMBER 23, 1992

To amend the District of Columbia Youth Services Act of 1976 to establish 2 Neighborhood Planning Councils in each election ward, to authorize the Mayor to adjust the boundaries of the Neighborhood Planning Councils, and to conduct Neighborhood Planning Council elections in even numbered years.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Youth Services Act of 1976 Amendment Act of 1992".

- Sec. 2. The District of Columbia Youth Services Act of 1976, effective March 29, 1977 (D.C. Law 1-93; D.C. Code § 1-2601 et seq.), is amended as follows:
- (a) Section 2(c) (D.C. Code § 1-2601(3)) is amended by striking the semicolon at the end thereof and inserting in its place the following phrase:
- ", subject to modifications made by the Mayor pursuant to section

(b) A new section 4a is added to read as follows:

"Sec. 4a. (a) There shall be 2 Neighborhood Planning Councils in each election ward established pursuant to section 2 of the Boundaries Act of 1975, effective December 16, 1975 (D.C. Law 1-38; D.C. Code § 1-1308). The Mayor, by rulemaking, shall draw boundaries for Neighborhood Planning Councils, after each decennial census, so that they are approximately equal in population.

"(b)(1) Regular elections for the Neighborhood Planning Councils shall be held in even numbered years on a date set by the Mayor by rulemaking.

- "(2) Any Neighborhood Planning Council member holding office immediately prior to the effective date of the District of Columbia Youth Services Act of 1976 Emergency Amendment Act of 1992 may continue to hold office until a successor is elected and qualifies for office pursuant to this act.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
