### D.C. LAW 9-202

"Stable and Reliable Source of Revenues for WMATA Act of 1982 Temporary Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-583 on first and second readings, July 7, 1992, and November 4, 1992, respectively. Following the signature of the Mayor on November 25, 1992, this legislation was assigned Act No. 9-327, published in the December 11, 1992, edition of the D.C. Register, (Vol. 39 page 9221) and transmitted to Congress on January 6, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-202, effective March 16, 1993.

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# NOVEMBER 25, 1992

To allow, on a temporary basis, the Washington Metropolitan Area Transit Authority to use debt service payments on outstanding federally guaranteed transit revenue bonds received from the District of Columbia for the refunding of these bonds.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Stable and Reliable Source of Revenues for WMATA Act of 1982 Temporary Amendment Act of 1992".

- Sec. 2. Section 2(e) of the Stable and Reliable Source of Revenues Note, Section for WMATA Act of 1982, effective April 30, 1982 (D.C. Law 4-103; D.C. 1-2466 Code § 1-2466(e)), is amended as follows:
- (a) By striking the phrase, "in accordance with the following priorities"; and
- (b) By amending paragraphs (1)(B) and (C) to read as follows:

  "(B) An amount equal to the Washington Metropolitan
  Area Transit Authority's ("WMATA") contribution to the sinking fund
  established by section 15(a)(1) of the National Capital Transportation
  Act of 1969 ("Act"), approved January 3, 1980 (93 Stat. 1321; D.C. Code
  § 1-2464(a)(1)) pursuant to section 15(a)(4) of the Act payable through
  the year 2014. These funds shall be used by WMATA to make debt
  service payments on the new bonds issued to refund the local share of
  the federally guaranteed transit revenue bonds; and
- "(C) An amount equal to the Washington Metropolitan Area Transit Authority's contribution to the Bond Interest Fund established by section 15(b)(1) of the Act, approved January 3, 1980 (93 Stat. 1321; D.C. Code § 1-2464(b)(1)), pursuant to section 15(b)(4) of the Act payable through the year 2014. These funds shall be used by WMATA to make debt service payments on the new bonds issued to refund the local share of the federally guaranteed transit revenue bonds.".
- Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District
