"Smoking Regulation Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-496 on first and second readings, December 1, 1992, and December 15, 1992, respectively. Following the signature of the Mayor on December 31, 1992, this legislation was assigned Act No. 9-354, published in the January 22, 1993, edition of the D.C. Register, (Vol. 40 page 590) and transmitted to Congress on January 15, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-223, effective March 17, 1993.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 31, 1992

To amend the District of Columbia Smoking Restriction Act of 1979 to delete the requirement for the size of the smoking signs and the size of the printed letters and to require that the signs include the internationally recognized smoking symbol.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Smoking Regulation Amendment Act of 1992".

- Sec. 2. Section 5(b) of the District of Columbia Smoking Restriction Section Act of 1979, effective September 28, 1979 (D.C. Law 3-22; D.C. Code § 6-914 6-914(b)), is amended to read as follows:
- "(b) Where smoking is prohibited pursuant to this act all signs posted shall include the internationally recognized no smoking symbol. Where smoking is restricted pursuant to this act all signs posted shall include the internationally recognized smoking symbol.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District
