"Motor Vehicle Specialty Tags Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-414 on first and second readings, December 1, 1992, and December 15, 1992, respectively. Following the signature of the Mayor on January 5, 1993, this legislation was assigned Act No. 9-373, published in the January 22, 1993, edition of the <u>D.C. Register</u>, (Vol. 40 page 625) and transmitted to Congress on January 15, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-239, effective March 17, 1993.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JANUARY 5, 1993

To amend the District of Columbia Revenue Act of 1937 to provide specialty tags for any person ordering such tags, including Advisory Neighborhood Commissioners, members of the District of Columbia National Guard, and persons belonging to an officially recognized organization tag group.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Motor Vehicle Specialty Tags Amendment Act of 1992".

Sec. 2. Section 3(a) of title IV of the District of Columbia Revenue Act of 1937, approved August 17, 1937 (50 Stat. 681; D.C. Code § 40-104(a)), is amended as follows:

Section 40-104

- (a) By inserting a period after the phrase "a fee not exceeding \$.50 in addition to all other fees which may be required", and striking everything that follows in the subsection:
- (b) By adding a new sentence at the end of the subsection to read as follows: "If the markings on any such tag are specially ordered by the person to whom the tag is to be issued, including an active Advisory Neighborhood Commissioner, a member of the District of Columbia National Guard, or a person belonging to an officially recognized organization tag group other than the Disabled American Veterans, and such markings are other than those in a regular series, a reservation fee of \$40 and an annual fee of \$20, in addition to all other fees which may be required shall be charged for such specially ordered tag.";
 - (c) By designating the existing text as paragraph 1; and
 - (d) By adding a new paragraph (2) to read as follows:
- "(2) The Mayor may modify the schedule of fees established in this subsection by rulemaking, pursuant to title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1204; D.C. Code § 1-1501 et seq.).".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District
