L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-584 on first and second readings, December 1, 1992, and December 15, 1992, respectively. Following the signature of the Mayor on January 14, 1993, this legislation was assigned Act No. 9-396, published in the January 29, 1993, edition of the <u>D.C.</u> <u>Register</u>, (Vol. 40 page 771) and transmitted to Congress on January 26, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-250, effective March 25, 1993.

D.C. ACT 9-396 (<u>1993</u> Supplement)

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JANUARY 14, 1993

To amend the Stable and Reliable Source of Revenues for WMATA Act of 1982 to allow the Washington Metropolitan Area Transit Authority to use debt service payments on outstanding federally guaranteed transit revenue bonds received from the District of Columbia for the refunding of these bonds.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Stable and Reliable Source of Revenues for WMATA Act of 1982 Amendment Act of 1992".

Sec. 2. Section 2(e) of the Stable and Reliable Source of Revenues Section for WMATA Act of 1982, effective April 30, 1982 (D.C. Law 4-103; D.C. 1-2466 Code § 1-2466(e)), is amended as follows:

(a) By striking the phrase, "in accordance with the following priorities"; and

(b) By amending paragraphs (1)(B) and (C) to read as follows:

"(B) An amount equal to the Washington Metropolitan Area Transit Authority's ("WMATA") contribution to the sinking fund established by section 15(a)(1) of the National Capital Transportation Act of 1969 ("Act"), approved January 3, 1980 (93 Stat. 1321; D.C. Code § 1-2464(a)(1)) pursuant to section 15(a)(4) of the Act payable through the year 2014. These funds shall be used by WMATA to make debt service payments on the new bonds issued to refund the local share of the federally guaranteed transit revenue bonds; and

"(C) An amount equal to the Washington Metropolitan Area Transit Authority's contribution to the Bond Interest Fund established by section 15(b)(1) of the Act, approved January 3, 1980 (93 Stat. 1321; D.C. Code § 1-2464(b)(1)), pursuant to section 15(b)(4) of the Act payable through the year 2014. These funds shall be used by WMATA to make debt service payments on the new bonds issued to refund the local share of the federally guaranteed transit revenue bonds.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
