D.C. LAW 9-31

"Cigarette Tax Amendment Act of 1991

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-164 on first and second readings, June 4, 1991, and June 18, 1991, respectively. Following the signature of the Mayor on July 2, 1991, this legislation was assigned Act No. 9-58, published in the July 12, 1991, edition of the <u>D.C. Register</u>, (Vol. 38 page 4218) and transmitted to Congress on July 9, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that this legislation became effective on the date that the President of the United States signed P. L. 102-105* on August 17, 1991, and therefore, cites this enactment as D.C. Law 9-31, effective August 17, 1991.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 2, 1991

To amend the District of Columbia Cigarette Tax Act to increase the tax imposed on cigarettes to 1.50 cents per individual cigarette.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Cigarette Tax Amendment Act of 1991".

Sec. 2. The District of Columbia Cigarette Tax Act, approved May 27, 1949 (63 Stat. 136; D.C. Code §47-2401 *et seq.*), is amended as follows:

(a) Section 603(a) (D.C. Code §47-2402(a)) is amended by striking the number "0.85" and inserting the number "1.50" in its place.

(b) Section 618 (D.C. Code §47-2418) is amended as follows:

(1) Subsection (a) is amended by striking the phrase "the effective date provided for in section 3(b) of the Cigarette Tax Amendment Act of 1986 ("effective date") or that are otherwise held on the effective date shall" and inserting the phrase "July 1, 1991, or that are otherwise held on July 1, 1991, shall" in its place.

(2) Subsection (a)(1) is amended by striking the phrase "the effective date" wherever it appears and inserting the phrase "July 1, 1991" in its place.

(3) Subsection (a)(2) is amended as follows:

(A) By striking the phrase "within 20 days after the effective date," and inserting the phrase "within 20 days after July 1, 1991," in its place; and

(B) By striking the phrase "as of the effective date" and inserting the phrase "as of July 1, 1991" in its place.

(4) Subsection (a)(3) is amended by striking the phrase "the effective date" and inserting the phrase "July 1, 1991" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Section 47-2402
