D.C. LAW 9-32

"District of Columbia Election Code of 1955  
Amendment Act of 1991".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-191 on first and second readings, June 4, 1991, and June 18, 1991, respectively. Following the signature of the Mayor on July 2, 1991, this legislation was assigned Act No. 9-59, published in the July 12, 1991, edition of the D.C. Register, (Vol. 38 page 4220) and transmitted to Congress on July 9, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that this legislation became effective on the date that the President of the United States signed P. L. 102-105\* on August 17, 1991, and therefore, cites this enactment as D.C. Law 9-32, effective August 17, 1991.

AN ACT

D.C. ACT 9-59

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 2, 1991

To amend the District of Columbia Election Code of 1955 to remove the requirement for an annual purge of non-voting registered electors.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Election Code of 1955 Amendment Act of 1991".

Sec. 2. Section 7(a) of the District of Columbia Election Code of 1955, approved August 12, 1955 (69 Stat. 699; D.C. Code §1-1311(a)), is amended as follows:


- (a) Paragraph (2) is repealed;
- (b) Paragraph (3) is repealed;
- (c) Paragraph (4) is repealed; and
- (d) Subparagraph (5)(B) is amended to read as follows:

"(B) The Board shall send notice to any person whose existing voter registration has been challenged and to any person whose name is alleged to have been erroneously omitted or dropped from the voter registration rolls if, in either instance, the registration cannot be verified by the Board's own records. The notice shall be sent to the address listed on the Board's records. The notice shall state that the person must execute an affidavit stating he or she is a qualified elector, and that the affidavit must be executed within 30 days from the mailing of the notice in order for the person to be listed on the District's voter roll."

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of
