#### D.C. LAW 9-33

"District of Columbia Housing Bonus Repealer Act of 1991".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-215 on first and second readings, June 4, 1991, and June 18, 1991, respectively. Following the signature of the Mayor on July 2, 1991, this legislation was assigned Act No. 9-60, published in the July 12, 1991, edition of the <u>D.C. Register</u>, (Vol. 38 page 4222) and transmitted to Congress on July 9, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that this legislation became effective on the date that the President of the United States signed P. L. 102-105\* on August 17, 1991, and therefore, cites this enactment as D.C. Law 9-33, effective August 17, 1991.

## D.C. ACT 9-60

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

# JULY 2, 1991

To repeal the housing bonus for District of Columbia employees.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Housing Bonus Repealer Act of 1991".

Sec. 2. Section 1117 of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 16, 1989 (D.C. Law 7-203; D.C. Code §1-612.18), is repealed.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
