D.C. LAW 9-35

"Uniform Disposition of Unclaimed Property Act of 1980 Amendment Act of 1991".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-114 on first and second readings, June 4, 1991, and June 18, 1991, respectively. Following the signature of the Mayor on July 12, 1991, this legislation was assigned Act No. 9-62, published in the July 26, 1991, edition of the <u>D.C. Register</u>, (Vol. 38 page 4609) and transmitted to Congress on July 16, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that this legislation became effective on the date that the President of the United States signed P. L. 102-105* on August 17, 1991, and therefore, cites this enactment as D.C. Law 9-35, effective August 17, 1991.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 12, 1991

To amend the Uniform Disposition of Unclaimed Property Act of 1980, to extend the periods of limitations in which the Mayor may commence an action or proceeding.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Uniform Disposition of Unclaimed Property Act of 1980 Amendment Act of 1991".

Sec. 2. Section 129(b) of the Uniform Disposition of Unclaimed Property Act of 1980, effective March 5, 1981 (D.C. Law 3-160; D.C. Code §42-229(b)), is amended by striking the phrase "ten (10)" wherever it appears and inserting the phrase "fifteen (15)" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
