IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JULY 24, 1991

To amend, section 15-718 of the District of Columbia Code to provide that a person summoned for petit jury service but not selected to serve on a petit jury shall not be paid an attendance fee.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Juror Fees Amendment Act of 1991".

Sec. 2. Section 15-718(a) of the District of Columbia Code is amended by adding a new sentence at the end to read as follows: "A person summoned for petit jury service in the Superior Court of the District of Columbia who does not serve on the petit jury shall not be paid an attendance fee.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
