The Council of the District of Columbia hereby gives notice that this legislation became effective on the date that the President of the United States signed P. L. 102-205* on December 10, 1991, and therefore, cites this enactment as D.C. Law 9-52, effective December 10, 1991.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCTOBER 23, 1991

To amend the Uniform Law on Notarial Acts of 1990 to require a certificate of a notarial act to include an official stamp or seal of office.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Uniform Law on Notarial Acts Amendment Act of 1991".

Sec. 2. The Uniform Law on Notarial Acts of 1990, effective March 6, 1991 (D.C. Law 8-205; D.C. Code §45-621 et seq.), is amended as follows:

Section 8(a) (D.C. Code §45-627(a)) is amended by striking (a) Note, the phrase "may include the official stamp or seal of office." and inserting Sec. 45-627 the phrase "shall include the official stamp or seal of office." in its place. Note,

(b) Section 9(5) (D.C. Code §45-628(5)), is repealed.

Sec. 3. This act shall apply as of March 6, 1991.

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of


