"Redistricting Procedure Amendment Act of 1991 Clarification Temporary Amendment Act of 1991".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-321 on first and second readings, October 1, 1991, and November 5, 1991, respectively. Following the signature of the Mayor on November 25, 1991, this legislation was assigned Act No. 9-106, published in the December 6, 1991, edition of the $\underline{D.C.}$ Register, (Vol. 38 page 7294) and transmitted to Congress on November 26, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-63, effective March 7, 1992.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOVEMBER 25, 1991

To amend, on a temporary basis, the Redistricting Procedure Act of 1981, as amended by the Redistricting Procedure Amendment Act of 1991, to clarify the legal description of the boundary between Wards 2 and 6.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Redistricting Procedure Amendment Act of 1991 Clarification Temporary Amendment Act of 1991".

Section 1-3333

- Sec. 2. Section 4 of the Redistricting Procedure Act of 1981, effective August 17, 1991 (D.C. Law 9-26; to be codified at D.C. Code §1-1333), is amended by striking the phrase "thence south along said South Capitol Street and continuing the projection of South Capitol Street south to the center line of the Anacostia River;" wherever it appears and inserting the phrase "thence south along said South Capitol Street and continuing southeasterly along said South Capitol Street to the midpoint of the Frederick Douglass Memorial Bridge / center line of the Anacostia River;" in its place.
- Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect or upon the effective date of the Redistricting Procedure Amendment Act of 1991 Clarification Amendment Act of 1991, whichever occurs first.
