L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-314 on first and second readings, November 5, 1991, and December 3, 1991, respectively. Following the signature of the Mayor on December 20, 1991, this legislation was assigned Act No. 9-116, published in the January 3, 1992, edition of the $\underline{\text{D.C.}}$ Register, (Vol. 39 page 8) and transmitted to Congress on January 7, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-65, effective March 11, 1992.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 20, 1991

To amend the Redistricting Procedure Act of 1981, as amended by the Redistricting Procedure Amendment Act of 1991, to clarify the legal description of the boundary between Wards 2 and 6; and to amend the Free Clinic Assistance Program Act of 1986 to extend the Free Clinic Assistance Program Act for 5 years.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Redistricting Procedure Amendment Act of 1991 Clarification and Free Clinic Assistance Program Act of 1986 Extension Amendment Act of 1991".

Sec. 2. Section 4 of the Redistricting Procedure Act of 1991, effective August 17, 1991 (D.C. Law 9-26; to be codified at D.C. Code §1-1333), is amended by striking the phrase "thence south along said South Capitol Street and continuing the projection of South Capitol Street south to the center line of the Anacostia River;" wherever it appears and inserting the phrase "thence south along said South Capitol Street and continuing southeasterly along said South Capitol Street to the midpoint of the Frederick Douglass Memorial Bridge / center line of the Anacostia River;" in its place.

New Section 1-333

- Sec. 3. Section 7(b) of the Free Clinic Assistance Program Act of 1986, effective September 23, 1986 (D.C. Law 6-155; D.C. Code §1-308.1 note), is amended to read as follows:

 "(b) This act shall expire 10 years after its having taken effect.".

- Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of

Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend the Redistricting Procedure Act of 1981, as amended by the Redistricting Procedure Amendment Act of 1991, to clarify the legal description of the boundary between Wards 2 and 6; and to amend the Free Clinic Assistance Program Act of 1986 to extend the Free Clinic Assistance Program Act for 5 years.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Redistricting Procedure Amendment Act of 1991 Clarification and Free Clinic Assistance Program Act of 1986 Extension Amendment Act of 1991".

Sec. 2. Section 4 of the Redistricting Procedure Act of 1991, effective August 17, 1991 (D.C. Law 9-26; to be codified at D.C. Code §1-1333), is amended by striking the phrase "thence south along said South Capitol Street and continuing the projection of South Capitol Street south to the center line of the Anacostia River;" wherever it appears and inserting the phrase "thence south along said South Capitol Street and continuing southeasterly along said South Capitol Street to the midpoint of the Frederick Douglass Memorial Bridge / center line of the Anacostia River;" in its place.

Sec. 3. Section 7(b) of the Free Clinic Assistance Program Act of Section 1986, effective September 23, 1986 (D.C. Law 6-155; D.C. Code §1-308.1 note), is amended to read as follows:

"(b) This act shall expire 10 years after its having taken effect.". Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of

Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
