D.C. LAW 9-73

"Merchant's Assistance Program Temporary Amendment Act of 1991".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-352 on first and second readings, November 5, 1991, and December 3, 1991, respectively. Following the signature of the Mayor on December 20, 1991, this legislation was assigned Act No. 9-125, published in the January 3, 1992, edition of the $\underline{\text{D.C.}}$ Register, (Vol. 39 page 25) and transmitted to Congress on January 7, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-73, effective March 11, 1992.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DECEMBER 20, 1991

To require, on a temporary basis, that the Office of Business and Economic Development create an emergency fund to assist the small businesses in the District of Columbia who have been adversely impacted by infrastructure construction initiated by the District government, by allowing such businesses relief in the form of short term financial assistance to be used for normal and customary operating business expenses.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Merchant's Assistance Program Temporary Amendment Act of 1991".

- Sec. 2. The Business and Economic Development Act of 1976, effective March 29, 1977 (D.C. Law 1-97; D.C. Code § 1-2201 et seq.), is amended by adding a new section 13 to read as follows:
- "Sec. 13(a) Create a fund for emergency loans or grants to assist small businesses located in identified target areas in the District of Columbia that have suffered an economic hardship due to infrastructure construction initiated by the District government or its authorized agent.
- "(b) The Mayor shall process a loan application under the emergency loan/grant program within 30 days of receipt of the application.
- "(c) Loans/grants shall be short-term and used for any normal and customary business operating expense.".
- Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
