"District of Columbia Government Comprehensive Merit Personnel Act of 1978 Council Review Period Temporary Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-387 on first and second readings, December 17, 1991, and January 7, 1992, respectively. The legislation was deemed approved without the signature of the Mayor on January 30, 1992, pursuant to Section 404(e) of "the Act", and was assigned Act No. 9-150, published in the February 7, 1992, edition of the D.C. Register, (Vol. 39 page 718) and transmitted to Congress on February 3, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-87, effective March 24, 1992.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JANUARY 30, 1992

To amend, on a temporary basis, the District of Columbia Government Comprehensive Merit Personnel Act of 1978 to provide that Council review of labor relations settlements coincide with the budget review process.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Government Comprehensive Merit Personnel Act of 1978 Council Review Period Temporary Amendment Act of 1992".

Sec. 2. Section 1717 of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code §1-618.17) is amended by adding a new subsection (j-1) to read as follows:

Note, Section 1-618.17

- "(j-1) Notwithstanding any other provision of this act:

 "(1) Labor relations settlements negotiated or otherwise determined pursuant to section 1717 pending before the Council on December 17, 1991, shall become effective on April 15, 1992, unless prior to April 15, 1992, the Council accepts or rejects a settlement by resolution.
- "(2) Except as provided in this paragraph, labor relations settlements for compensation earned or to be earned in fiscal years 1991, 1992 and 1993 shall be submitted on or before February 14, 1992, and shall become effective on April 15, 1992, unless prior to April 15, 1992, the Council accepts or rejects a settlement by resolution. Labor relations settlements for compensation earned or to be earned in fiscal years 1991, 1992 and 1993 and submitted after February 14, 1992, shall be submitted with a supplemental budget and shall take effect on the 30th day after the Mayor and the Council enact the budget request act, unless prior to the 30th day, the Council accepts or rejects a settlement by resolution."
- Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of
